South Australia is having an election to elect representatives for the South Australian First Nations Voice to Parliament on Saturday, 16 March 2024.

This toolkit is to support South Australian Aboriginal and Torres Strait Islander communities.

In it, you'll find factual information to share with your networks about the upcoming South Australian First Nations Voice to Parliament and the South Australian First Nations Voice to Parliament Election.



# What is the First Nations Voice to South Australian Parliament?

The South Australian First Nations Voice to Parliament or SA First Nations Voice, is a state-level initiative led by the South Australian Government to provide a connected, direct and independent line of communication for Aboriginal and Torres Strait Islander people living in South Australia to the South Australian Parliament and the Government.

The SA First Nations Voice will be made up of Aboriginal and Torres Strait Islanders, elected by the Aboriginal and Torres Strait Islander people of South Australia. They will represent their communities and provide advice on laws, policies, and programs through direct communication with key decision-makers.

The SA First Nations Voice will enable more informed and inclusive decision-making about the issues that matter most to Aboriginal and Torres Strait Islander people and their communities.

# What is the South Australian First Nations Voice to Parliament Election?

The South Australian First Nations Voice to Parliament Election is the process for Aboriginal and Torres Strait Islanders in South Australia to elect their representatives to the South Australian First Nations Voice to Parliament.

To form the Six Local First Nations Voice bodies, The Electoral Commission of South Australia (ECSA) will be holding an election on Saturday, 16 March 2024, which will allow South Australian Aboriginal and Torres Strait Islanders to elect the members of each Local First Nations Voice.

Only Aboriginal and Torres Strait Islanders living in South Australia can vote (and nominate as a candidate) in the South Australian First Nations Voice to Parliament Election.

The election will be held on Saturday, 16 March 2024.

# The South Australian First Nations Voice to Parliament and the Federal Referendum:

What is the difference?

The Federal Referendum and the South Australian First Nations Voice to Parliament are 2 separate but related initiatives. Both are based on the recommendations of the Uluru Statement from the Heart, which was the outcome of a national Indigenous constitutional convention held in 2017.

The 2 initiatives share a common goal of promoting greater Aboriginal and Torres Strait Islanderrepresentation and self-determination in decision-making and the development of laws, policies, and programs.

The key difference is the federal referendum sought to establish a voice to the Federal Parliament through making a change to the Australian Constitution. The South Australian Government has legislated a Voice to speak to the State Parliament.

The result of the Federal Referendum does not affect the establishment of the SA Voice to Parliament or the SA Voice to Parliament Election being held in March 2024.

South Australian Government commits to implementing the Uluru Statement.

# The South Australian First Nations Voice to Parliament and the Federal Voice Referendum: Key differences

## The South Australian First Nations Voice to Parliament

The South Australian First Nations Voice will be made up of Aboriginal and Torres Strait Islanders who are elected by the Aboriginal and Torres Strait Islander people of South Australia.

These community representatives will provide advice on laws, policies and programs through direct communication with key decision-makers, enabling more informed and inclusive decision-making about the issues that matter most to Aboriginal and Torres Strait Islanders and their communities.

# The South Australian First Nations Voice to Parliament Election

The SA First Nations Voice to Parliament Election is the process for Aboriginal and Torres Strait Islander people in South Australia to elect these representatives.

# ■ Voting in the South Australian First Nations Voice to Parliament Election

This is the election to choose the people to represent South Australian Aboriginal and Torres Strait Islanders on the South Australian First Nations Voice to Parliament.

### This election will be held on Saturday, 16 March 2024.

Eligible South Australian Aboriginal and Torres Strait Islanders will vote to choose their representatives in the SA First Nations Voice to Parliament. Only eligible Aboriginal and Torres Strait Islanders living in South Australia can vote (and nominate as a candidate) in the election.

The ballot paper will have the photos and names of candidates running for election, and voters have to number their preferred candidates in order of preference.

Voting in the SA First Nations Voice to Parliament Election is not compulsory.



# The South Australian First Nations Voice to Parliament and the Federal Voice Referendum: Key differences

# The Federal Voice Referendum

The Federal Referendum was held on 14 October 2023.

This is where you voted Yes or No.

The majority of the Australian population voted not to enshrine a First Nations Voice in the Australian Constitution.

The result of the Federal Referendum does not affect the establishment of the SA Voice to Parliament or the SA Voice to Parliament Election being held in March 2024.

### What was the Federal Referendum?

The Federal Aboriginal and Torres Strait Islander Voice to Parliament Referendum referred to the proposal to enshrine an advisory body (Voice) to the Federal Parliament into the Australian Constitution.

A national referendum was held because all Australians must have their say on any changes to the Australian Constitution.

On referendum day, you voted 'yes' or 'no' to the following question:

"A Proposed Law: to alter the Constitution to recognise the First Peoples of Australia by establishing an Aboriginal and Torres Strait Islander Voice.

Do you approve this proposed alteration?"

Voting in the Federal Referendum was compulsory for all Australians over 18 years of age.

# Voting in The Federal Voice Referendum

The Federal Voice Referendum was held on 14 October.

This is where you voted Yes or No on the proposed alteration to the Australian Constitution.

On 14 October, the majority of the Australian population voted not to enshrine a First Nations Voice in the Australian Constitution.

Voting in the referendum was compulsory for all Australians over 18.

# How does The First Nations Voice to South Australian Parliament work?

South Australia's First Nations Voice will have 2 levels, a Local First Nations Voice and a State First Nations Voice. They will work together but will have different roles and responsibilities.

# **1 Local First Nations Voice**

There are 6 regions across South Australia, with an elected body for each of the 6 regions.

Of the 6 regions:

- 5 will have 7 elected members.
- 1 (the Central Local First Nations Voice region) will have 11 elected members, as it has a higher population of Aboriginal and Torres Strait Islander people.
- There will be a balanced number of men and women.

The election for the Local First Nations Voice representatives will be held on 16 March 2024.

All elected members will be Aboriginal and Torres Strait Islander people. They will be elected by the Aboriginal and Torres Strait Islander people who live in the region.

### Roles and responsibilities

The Local First Nations Voice bodies will:

- talk to and listen to local Aboriginal and Torres Strait
   Islander people about issues that matter to them
- engage with government or other organisations in the local area, including local councils
- share their community's views with the State First Nations Voice.

Each Local First Nations Voice will choose 2 joint presiding members

These joint presiding members will chair the local voice meetings and act as their regions representatives on the State First Nations Voice.

# How does The First Nations Voice to South Australian Parliament work?

# How does The First Nations Voice to South Australian Parliament work?

South Australia's First Nations Voice will have 2 levels, a Local First Nations Voice and a State First Nations Voice. They will work together but will have different roles and responsibilities.

# 2 State First Nations Voice


The State First Nations Voice will have 12 members. It will be made up of the 2 joint presiding members from each of the 6 Local First Nations Voices.

The State First Nations Voice will choose 2 of their members of different genders to become the joint presiding members. These 2 joint presiding members will lead the State First Nations Voice by engaging directly with Parliament on behalf of the State First Nations Voice.

## Roles and responsibilities

The State First Nations Voice will:

- hear the views of each Local First Nations Voice
- form state-wide views and positions that represent the diversity of Aboriginal and Torres Strait Islander people in South Australia
- present those views to the South Australian Parliament, ministers, and government chief executives





# How do you talk to people about the South Australian First Nations Voice to Parliament Election?

- The South Australian First Nations Voice to Parliament Election and the Federal Voice Referendum are different.
- People will be talking about the Federal Voice Referendum and the No result, when the majority of the Australian population voted not to enshrine a First Nations Voice in the Australian Constitution.
- The Federal Referendum is different to the South Australian First Nations Voice to Parliament and the No vote at the referendum doesn't affect the setup or the election being held to elect The South Australian First Nations Voice to Parliament which is already legislated.
- They may not know what the South
   Australian First Nations Voice to Parliament
   is and that an election is being held on
   Saturday, 16 March 2024.
- In the South Australian First Nations Voice to Parliament Election, you will be asked to vote for **candidates** to represent you.

- In the Federal Voice Referendum, you were be asked to vote Yes or No to changing the Australian Constitution.
- Voting in the Federal Voice Referendum was compulsory, and all Australians over 18 had to vote.
- Voting in the South Australian First Nations Voice to Parliament Election is not compulsory, and only eligible South Australian Aboriginal or Torres Strait Islanders can vote.
- To vote or nominate as a candidate in the South Australian First Nations Voice to Parliament, you have to be enrolled to vote.
- Ask people what they know about the Federal Voice Referendum and the South Australian First Nations Voice to Parliament.
- Give the toolkit materials to people and yarn about them.
- Discuss the facts through some key questions.

# **Quick facts**

# What is the South Australian First Nations Voice to Parliament Election?

This is the election to choose the people to represent South Australian Aboriginal and Torres Strait Islanders on the South Australian Voice.

The result of the Federal Referendum does not affect the establishment of the SA Voice to Parliament or the SA Voice to Parliament Election being held in March 2024.

This election will be held on **Saturday**, **16 March 2024**.

South Australian Aboriginal and Torres Strait Islanders will vote to choose their representatives for their Local First Nations Voice.

Only eligible Aboriginal and Torres Strait Islanders living in South Australia can vote (and nominate as a candidate) in the Election.

The ballot paper will have the names of candidates running for Election, and voters have to number their preferred candidates in order of choice.

Voting in the SA First Nations Voice to Parliament Election is not compulsory.

The Electoral Commission of South Australia (ECSA) will be running the election.

# **Enrolment**

Only Aboriginal and Torres Strait Islander people are eligible to nominate to be a candidate and to vote.

To vote or to run as a candidate in the South Australian Voice to Parliament Election, you must be on the electoral roll.

You are already on the electoral roll if you vote in South Australian State or Federal elections.

If you are on the electoral roll, please check your enrolment details at **savoiceelection.sa.gov.au** or by calling **1300 655 232**.

If you are not on the electoral roll, you must enrol before **5:00pm, 12 February 2024** to vote in the SA First Nations Voice to Parliament Election.

To enrol go to savoice election.sa.gov.au.

## **Nominations**

Nominating means putting your hand up to run as a candidate in the South Australian Voice to Parliament Election.

Any Aboriginal and Torres Strait Islander can nominate to run as a candidate for their Local First Nations Voice as long as they meet the relevant criteria.

More information on the eligibility criteria to nominate can be found at savoiceelection.sa.gov.au.

Aboriginal and Torres Strait Islanders living in their Local First Nations Voice region will vote to elect their representatives from the candidates who have nominated for that Local Voice Region.

Nominations open on 22 January 2024 and close at 5:00pm, 12 February 2024.

Nominating to run as a candidate is easy. You can download a nomination pack now at **savoiceelection.sa.gov.au** or call **1300 655 232** to have a nomination pack sent to you.

Alternatively, from 22 January 2024 you can complete and submit your nomination electronically through the SA Voice Election nomination portal at **savoicelection.sa.gov.au**.

# **Quick facts**

# **Voting**

The South Australian First Nations Voice to Parliament Election will be held on **Saturday, 16 March, 2024**.

Eligible voters can attend a polling booth on election day just as you would at a state or federal election.

There will be polling booths across the state where eligible electors can vote in person. Locations will be advertised closer to polling day.

If you are unable to attend a polling booth on polling day, there are other options to make sure you can cast your vote.

1 Early Voting - Wednesday 6 March 2024 to Friday 15 March 2024 Early Voting Centres will be set up across the state during the two weeks before polling day. Eligible electors who cannot attend a polling booth on 16 March 2024 may cast their vote at an Early Voting Centre.

Locations will be advised closer to the day at **savoiceelection.sa.gov.au**.

**2 Postal Voting** – If you are unable to attend a polling booth or Early Voting Centre, Postal Vote applications will be available from 29 January 2024.

Complete the application and return it to ECSA to receive your Postal Voting Pack. Postal Voting Packs containing your ballot papers will be sent out via post the week of **Monday**, **4 March 2024**.

3 Mobile Polling – Mobile polling will be conducted in regional and remote locations across South Australia between Monday,
4 March 2024 to Friday, 15 March 2024.

Mobile polling locations and times will be advised closer to the election date at **savoiceelection.sa.gov.au**.

# **Election results**

The counting of votes for the South
Australian First Nations Voice to Parliament
will begin Monday, 25 March 2024, one week
after election day, to ensure that all postal
votes arrive to be included in the count.
Results may not be known for several days
after the count starts.

Once the election is declared, successful candidates will be contacted by the South Australian First Nations Voice Secretariat and the First Nations Voice for each region will be formed.

# What happens next?

After the election, Each Local First Nations Voice will meet to elect 2 representatives as their joint presiding members.

These presiding members will represent their region on the State First Nations Voice.

The next South Australian First Nations Voice Parliament Election will be held to coincide with the 2026 South Australian State Election, and the elected term will be four years from this Election.

# **Key messages**

# The South Australian Voice to Parliament Election

- The South Australian Government is holding elections on 16 March 2024 to elect representatives for the First Nations Voice to the South Australian Parliament.
- This is a different event from the Federal Voice Referendum.
- Eligible South Australian Aboriginal and Torres Strait Islanders will vote to choose their representatives in the SA First Nations Voice to Parliament.
- Voting means voting for South Australian Aboriginal and Torres Strait Islander candidates who have put their hands up to be local representatives.
- Only Aboriginal and Torres Strait Islanders on the South Australian electoral roll can vote in the First Nations Voice to the South Australian Parliament.
- To vote or nominate as a candidate, make sure you are on the SA electoral roll.
- If you vote in SA state and federal elections, you are already on the electoral roll; just ensure that your details are current.
- If you are not on the electoral roll you can put your name on the roll at savoiceelection.sa.gov.au.
- Voting in the SA First Nations Voice to Parliament Election is not compulsory.
- The ballot paper will have the names and photos of candidates running for Election, and voters have to number their preferred candidates in order of preference.

### **Federal Voice Referendum**

- On 14 October, the majority of the Australian population voted not to enshrine a First Nations Voice in the Australian Constitution.
- The Federal Referendum is different to the South Australian First Nations Voice to Parliament and the No vote at the referendum doesn't affect the setup or the election being held to elect The South Australian First Nations Voice to Parliament which is already legislated by The SA Government.
- Voting in the Federal referendum was compulsory for all Australian Citizens aged over 18.
- If you voted in the Federal Referendum and live in SA, you are already enrolled to vote in the South Australian First Nations Voice to Parliament Election. Just make sure your details are up to date.

Only South Australian Aboriginal and Torres Strait Islanders can vote in the SA Voice to Parliament Election.



### Is the SA Voice to Parliament and the Federal Voice Referendum the same thing?

There has been a lot of talk about Referendums and the South Australian Voice to Parliament, and it can be hard to know the difference at times, and sometimes it also be confusing trying to understand the difference.

Both of these came out of the Uluru Statement from the Heart and share the common goal of promoting greater Aboriginal and Torres Strait Islander representation.

The Federal Voice Referendum refers to the National Referendum that was held on 14 October 2023.

At the Federal one, you were asked to vote yes or no to enshrining a First Nations Voice in the Australian Constitution.

Voting in the Federal referendum was compulsory for all Australian citizens over 18.

The No result in the Federal Referendum does not affect the setting up of the South Australian First Nations Voice to Parliament or the election of South Australian First Nations Voice to Parliament representatives on 16 March 2024.

**The South Australian First Nations Voice to Parliament** is different to the Federal Voice Referendum. It will make sure Aboriginal and Torres Strait Islander people living in South Australia can talk straight to the South Australian Government on the important things for their community.

You will vote to choose who you think will be the right people to talk for your community. If they are elected, these people will speak for their local communities and Aboriginal and Torres Strait Islanders across the state in South Australia.

Voting in the SA First Nations Voice to Parliament Election is not compulsory and only South Australian Aboriginal and Torres Strait Islanders can vote in the election.
